Controlled Visitation Resumes at NSUH

Effective Immediately Visitation Guidelines

Guidelines are subject to change



For your safety we have implemented
the following guidelines



- One visitor over the age of 18 is permitted
- Visits are reserved to 2 hours each day between 12pm-8pm, unless otherwise authorized
- Bedside visit is not to exceed 2 hours per day
- Upon hospital entry, visitor will undergo symptom and temperature checks
- Visitation will not be permitted for COVID-19 designated units (*excluding medical necessity*)
- Visitor will be required to wear a mask while in the facility, gloves are not permitted
- Visitor must remain in the patient's room at all times
- Visitor must practice hand hygiene and wash or sanitize their hands when entering and exiting a patients room
- Social distancing must be maintained during the visit
- Inpatient: 1 visitor is permitted between 12pm-8pm*
- Katz Women's Hospital: 1 support person is permitted (visiting hours do not apply)
- Emergency Department, peri-operative and procedural areas: visitors are not permitted*
- Outpatient office and clinic appointment: visitors are not permitted*
- For the safety of patients, loved ones, and staff, any visitor that does not abide by these guidelines will be asked to leave

*Excludes pediatrics, end of life and patients with an intellectual, developmental or other cognitive disability.

We sincerely appreciate your understanding as we work together to keep patient healing our top priority. To promote connection virtual technology is available and encouraged.

N95/PPE POD

The PPE Point of Distribution
will be transitioning to a weekdays only schedule

Beginning 6/12, the PPE POD will be open Monday-Friday 7am-8pm** offering:

- ▽ Convenient, accessible location for units/depts to send a team member
- ▽ All PPE items available including gowns, face shields, goggles, to supplement regular Materials delivery
- ▽ Sole distribution point for unit/dept supply of N95 during hours of operation
 - Authorized unit/department may send a representative anytime during hours of operation to pick up a daily par of N95 respirator masks.
- ▽ *Note: Departments with a daily N95 allotment can retrieve double their daily par on Fridays to ensure adequate supply and access for their weekend team members.*

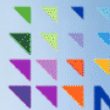
